

**“WPT PRIME \$2K ENTRY PASSPORT SOCIAL COMPETITION”
TERMS AND CONDITIONS**

1. The Star Pty Limited ABN (78 010 741 045) (“The Star Gold Coast”) is the promoter of the “WPT PRIME \$2K ENTRY PASSPORT SOCIAL COMPETITION” (“Promotion”) which commences from 12:00pm AEST Thursday, 2 June and ends at 12:00pm AEST on Wednesday 8 June 2022 (“Promotional Period”).

ELIGIBILITY

2. Participation in the Promotion is limited to persons who, insofar as is the case for the duration of the Promotional Period: a. 18 years of age or over; b. Not excluded from The Star Entertainment Group; and c. Resides in Queensland, Australia.
3. The promoter reserves the right, at its sole and absolute discretion, to deem any irregular entries, including the following entries (“Invalid Entries”): a. An Entry from a person who is not an Eligible Entrant; b. An Entry that is fraudulent or forged; and c. An Entry that appears to have been tampered with.
4. Invalid Entries cannot win the prize.

PARTICIPATION

5. To enter the Promotion, Eligible Entrants must: a. Like @starpokergoldcoast on Facebook; b. like the promotional post; and c. Comment which WPT Prime event they’re most looking forward to and tag three friends in this comment.
6. The Star Gold Coast reserves the right to verify the validity of any Entry. The Star Gold Coast may, in its sole discretion, disqualify any Entry from, and prohibit further participation in this Promotion by, any person who tampers with or benefits from any tampering with the entry process or with the operation of the Promotion and reserves the right to disqualify any entry which is not submitted in accordance with these conditions of entry.
7. No Entry will be accepted after 12:00pm AEST on Wednesday 8 June.

PRIZE INCLUSION

8. There will be a maximum of one (1) Prize Winner for this promotion. The Prize Winner will win (subject to these terms and conditions): one (1) WPT Prime Gold Coast entry passport to the value of \$2,000.
9. The Prize Winner will be able to use this passport to cover entry and admin fees into any 2022 WPT Prime Gold Coast events they wish to participate in, up to the value of \$2,000.
10. The Prize Winner will be responsible for covering the costs of any entry or admin fees greater over and above the \$2,000 prize value. No change will be given for any unspent passport funds.
11. The Prize Winner may use any or all of the passport funds to cover entry or admin fees of additional persons other themselves.

DRAW

12. There will be a prize draw (“Prize Draw”) at 3.00pm on Wednesday 8 June, 2022.

13. At the Prize Draw, one (1) Entry will be randomly selected from the entrants (“Drawn Entry”) by a random generator. A representative of Promoter will review the Drawn Entry to confirm eligibility into the Promotion.
14. If a Drawn Entry is deemed an Invalid Entrant or Invalid Entry, it will not be considered as a valid draw and an additional Entry will be drawn until a Drawn Entrant is not deemed to be an Invalid Entrant nor an Invalid Entry (“Prize Winner”).

NOTIFICATION OF WINNER

15. A representative of the Promoter will use reasonable efforts to contact the Prize Winner within forty-eight (48) hours of the Prize Draw and organize prize collection. The Prize Winner must produce Valid ID that is valid and acceptable to the representative of the Promoter in order to claim their prize.

“Valid ID” means:

- a. a passport, Australian driver’s license or other form of photographic identification in which the photograph is clear and undamaged and that is otherwise acceptable to The Star Gold Coast; or b. One form of non-photographic identification that are valid and acceptable to The Star Gold Coast.
16. The promoter reserves the right to waive or vary the identification requirements at its sole discretion in circumstances where the identity of a Winner is determinable by a representative of the promoter without the assistance of these or any other form of identification.
 17. The Prize Winner will have three (3) days to claim their prize from the Promoter and they may make inquiries by emailing brett.carter@star.com.au. If a Prize Winner cannot be contacted or cannot produce Valid ID within three (3) days after the Prize Draw, the Prize Winner will be deemed to have forfeited the prize in whole, no substitute will be offered and is an invalid selection (“Invalid Selection”).

REDRAWS

18. If a Drawn Entrant is considered an Invalid Selection, a redraw will occur with existing Entries. The Promotor will endeavour to inform Eligible Entrants who have Entries to the Prize Draw about redraw details through Facebook.
19. Re-drawn entrants will have 24 hours to claim their prize. This process will be repeated until a Prize Winner is found.

GENERAL

20. Guests must be 18 years or over to enter the casino.
21. The promotion is not sponsored, endorsed or administered by, or associated with, Facebook or Instagram.
22. Except as expressly provided in these terms and conditions, Entries and the Prize cannot be redeemed for cash or other goods and services.
23. The promoter reserves the right to cancel or change the prizes offered under the Promotion if there are any changes to the law that would or might render the Promotion or any prizes offered under the Promotion unlawful.
24. Conduct of the entire Promotion, including decisions on the eligibility of persons to enter and validity of entry and prizes, shall be the responsibility of the promoter. The promoter’s decisions in relation to the conduct of the Promotion are final.

25. The promoter needs to collect and use the personal information of entrants so that the entrant can be entered into the Promotion and the Promoter can administer the Promotion. Without providing the promoter with that information, the promoter cannot enter the person in the Promotion. The Promoter may disclose your personal information, including details of winners where required or authorised to do so by or under law or the disclosure is reasonably necessary to enforce the law. This may occur under the laws that apply to the Promoter's business, for example, where a regulatory authority requests information from the Promoter.
27. The promoter is not responsible for any problem or technical malfunction of any communications network or any late, lost, incorrectly submitted, delayed, ineligible, incomplete, corrupted or misdirected entry whether due to error, transmission interruption or otherwise. The promoter reserves the right to disqualify any entrant submitting an entry which, in the opinion of the promoter, includes objectionable content, including but not limited to profanity, nudity, potentially insulting, scandalous, inflammatory or defamatory images or language. The judges' decision is final and no correspondence will be entered into. Chance plays no part in determining the winner.
28. The promoter is not responsible for any loss, damage or injury suffered or claimed, including, but not limited to, indirect or consequential loss or damage, personal injury or death, and direct or indirect loss or damage by an entrant in relation to entering or participating in this Promotion or taking or using the prizes offered except where that loss, damage or injury was caused by breach of these terms and conditions by the promoter or the wilful or negligent acts or omissions of the promoter. To avoid any doubt the promoter shall not be liable for loss caused by technical and mechanical malfunction which is outside the control of the promoter.
29. If for any reason this competition is not capable of running as planned for any reason beyond the Promoter's control, including but not limited to infection by computer virus, bugs, tampering, unauthorised intervention, fraud, technical failures or any other causes beyond the control of the promoter which corrupt or affect the administration security, fairness, integrity or proper conduct of this competition, the promoter reserves the right in its sole discretion to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the competition.
30. To the extent that a situation, malfunction, or other issue arises for which these Terms and Conditions make no provision or in relation to which the relevant terms and conditions are unclear, the Promoter reserves the right to (a) make a decision regarding those circumstances which is not inconsistent with these Terms and Conditions; and/or (b) postpone the draw/s to a time and place which will allow the draw to be conducted in accordance with all terms and conditions other than those terms and conditions which specify the time and place of the draw/s.
31. The promoter assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorised access to, or alteration of, entries.
32. The promoter is not responsible for any problems or technical malfunction of any telephone network or lines, computer online systems, servers or providers, computer equipment, software, failure of any email or entry to be received by the promoter on account of technical problems or traffic congestion on the Internet or at any Website, or any

combination thereof, including any injury or damage to participant's or any other person's computer related to or resulting from participation or downloading any materials in this competition.

33. The Prize Winner and any other person(s) nominated to share the Prize with the Prize Winner agrees to accept, receive and use the Prize at their own risk and will, at all times, indemnify, keep indemnified, hold harmless and release The Star Gold Coast to the full extent permitted by law from and against any and all claims, causes of action, losses, damage, liability, cost or expense (including legal expenses on a full indemnity basis), incurred by The Star Gold Coast as a result of or in connection with the Promotion and from all liability which may arise in respect of any accident, damage or injury occurring to any person or property in connection with the Prize and / or the Prize Winner. The Prize Winner and any other person(s) nominated to share the prize with the Prize Winner will be required to sign an agreement to release The Star Gold Coast from and indemnify The Star Gold Coast against any liability arising from the use or participation in the prize.

In all other respects, the Promoter's decision is final, and no correspondence will be entered into
